WORK EXPERIENCE

1. In the period of 1978-1982 he worked on the Kopenhagen Coal "Kosovo" in Belacevec, where he passed the professional path from a graduate economist to the head of the Planning and Analysis Service. In this company, among other things, he worked on the realization of several projects, making analyzes regarding insufficient physical volume of coal production and financial effects on this basis, given the ratio of waste and coal on this 2: 1 coal (the most favorable in Europe), and the productivity of labor in this branch of production, the smallest in Europe and dr.
2. In the period 1982-1997, he worked with the Ministry of Internal Affairs of the Republic of Serbia in the affairs of the inspector for the suppression of economic criminality, the senior inspector for combating economic crime, the head of the Department for the suppression of economic crime and the head of the OUP.

In the period 1997-2009, he worked in the Ministry of Finance, the Republic Public Revenue Administration, now to the Tax Administration at the positions of the Chief of the Regional Financial Police Center, Head of the Regional Tax Police Department and Head of the Department for Monitoring and Guidance of the Regional Tax Department Belgrade, Novi Sad, Kragujevac and Nis. During this period, its contribution to the reform of the tax system is significant, especially in the introduction and implementation of VAT and fiscal decentralization.
